DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km by road from our warehouse to the local point of distribution into the market in Europe.

Packaging is compliant with european directive 2004/12/EU concerning packaging and packaging waste. At their end of life, its recyclability rate is 95 % (in % of packaging weight).

■ END OF LIFE

The product end-of-life factors are taken into account during the design phase.
